## UniCredit provides a 7.5 million euro loan to LATI Industria Termoplastici Spa, a Varese-based company in the rubber and plastics sector, with ESG-linked rate hedging and SACE Italian Guarantee for Mid Caps

Vedano Olona (Va), 30 April 2021 - Following the cooperation protocol signed with SACE to support the liquidity of Italian companies affected by the Covid-19 emergency, UniCredit has granted the first ESG-linked loan in Lombardy, digitally guaranteed by SACE through Garanzia Italia, to LATI Industria Termoplastici Spa, a Varese-based company operating in the Rubber and Plastics sector.

The loans, sustainability linked loan type, are characterised by the application of a mechanism that provides for the reduction of the interest rate to the borrower that will be applied to the ESG-linked lines with a pricing grid depending on future ESG rating certifications and the presence of Ecovadis certified ESG rating.

At the same time as the loan, an ESG Interest Rate Swap was negotiated that allows the company to mitigate the risk of rising interest rates with a mechanism to reduce the fixed rate of the transaction that is likewise linked to the company's ESG rating.

The financing package consists of a 6-year bilateral loan of 6.250 million euros, backed by SACE's Italian Guarantee dedicated to Mid Caps, intended to support LATI Spa's investments and working capital, and a bilateral unsecured loan of 1.250 million euros.

This transaction confirms that UniCredit is fully operational on all possible solutions under the Liquidity Decree.

LATI Industria Termoplastici Spa, founded in 1945 in Vedano Olona by the Conterno family, initially specialised in the production of cellulose acetate compounds, facilitated by the presence of materials granted to the Italian people by the Marshall Plan, such as synthetic underwear and slips, plastic military masks and many other items that LATI selected and recycled. Today LATI Industria Termoplastici Spa is one of the leading manufacturers of high performance engineering thermoplastics that are mainly used in the electrical, household, industrial and transport sectors.

The company is characterised by a production capacity of 40,000 tonnes at its two sites in Vedano Olona and Gornate Olona, 2,400 active formulations, 282 employees and approximately 2,000 customers. In 2020, the Group achieved sales of EUR 130.9m, with an EBITDA of EUR 17.3m and a profit of EUR 9.7m.
