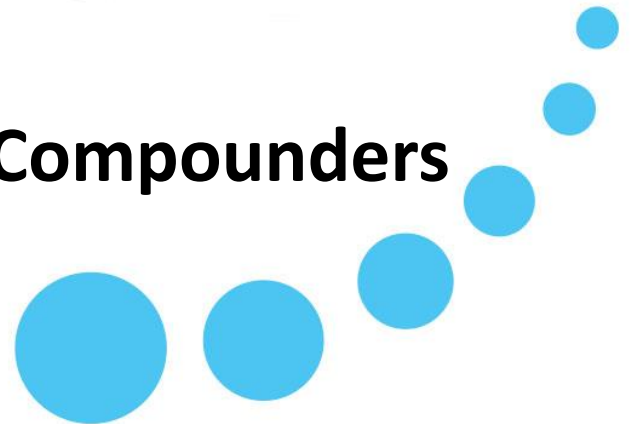

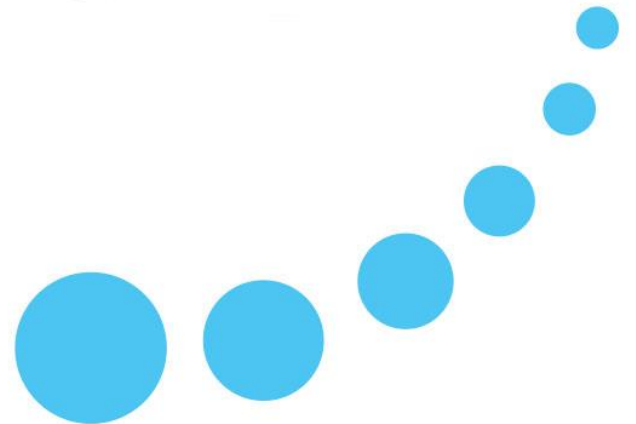

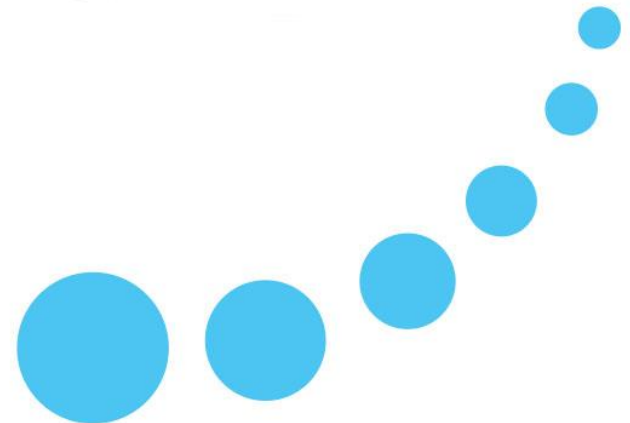
EuMBC - Who we are



The voice of the European Masterbatchers and Compounders

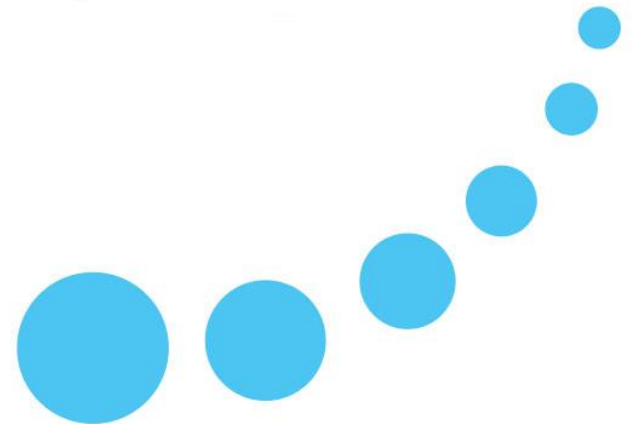
- An association of companies who have manufacturing operations in EU, EEA* and Turkey

** The European Economic Area covers EU28, Norway, Iceland, Liechtenstein*

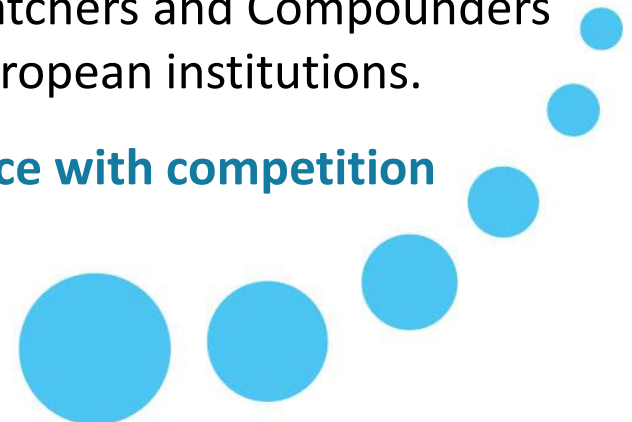

EuMBC – Our Mission

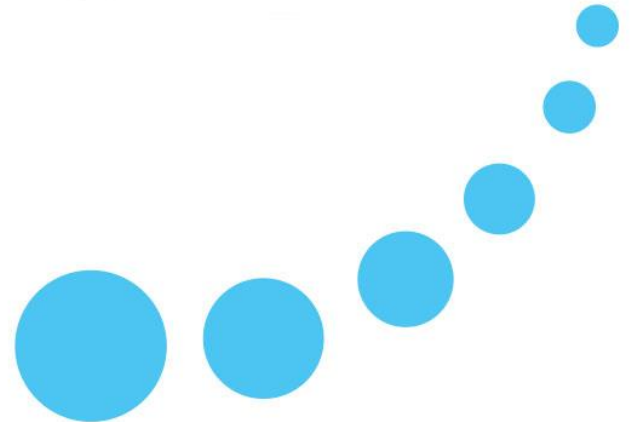


- **To represent the European Masterbatchers and Compounders**, and to stimulate their role across the entire plastics value chain.

- **To act in a responsible manner and in accordance with competition laws.**





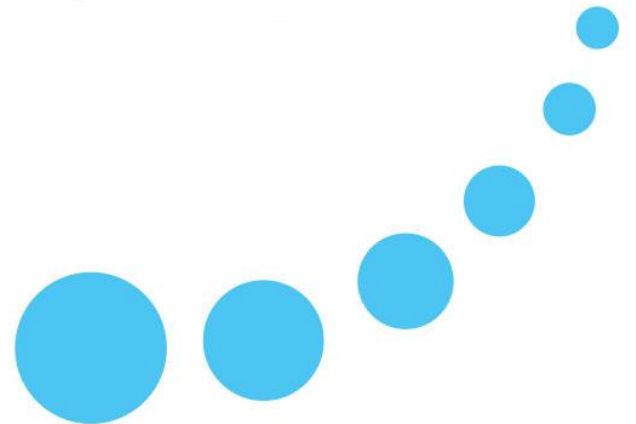

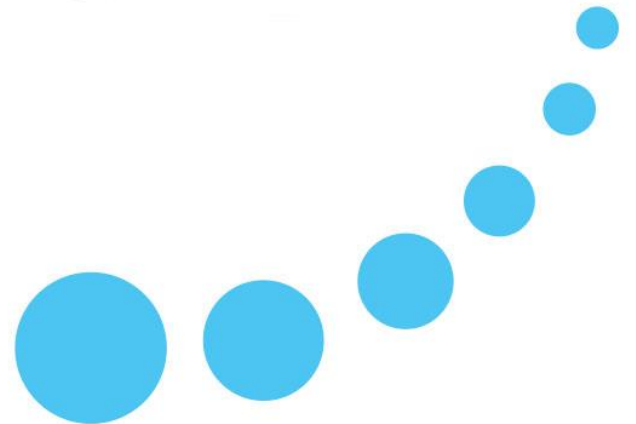

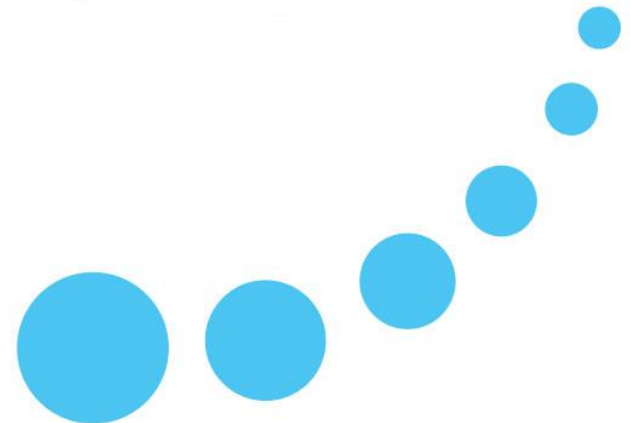
- **Participate in the EuMBC Substance Monitoring Group: technical, regulatory & monitoring activities for the association members**

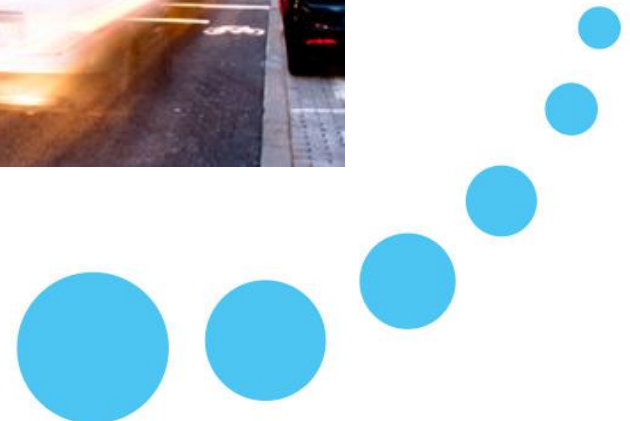
